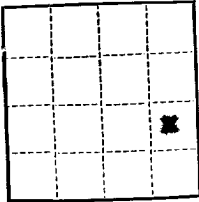

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

1. Approximately 30 ft. of conductor pipe will be set & cemented.
2. An 8-1/4" hole will be drilled to approximately 900 ft. at which depth 7" casing will be set and cemented with sufficient cement to fill the calculated annulus. This string will be set into the Rustler Anhydrite.
3. A 6-1/4" hole will be drilled through the Grayburg to an approximate depth of 3200 ft.
4. A gamma-ray sonic log and a laterolog will be run.
5. 4-1/2" casing will be run to TD and cemented with approximately 100 sacks of cement.
6. The pay intervals, as determined from the logs, will be perforated and free treated.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

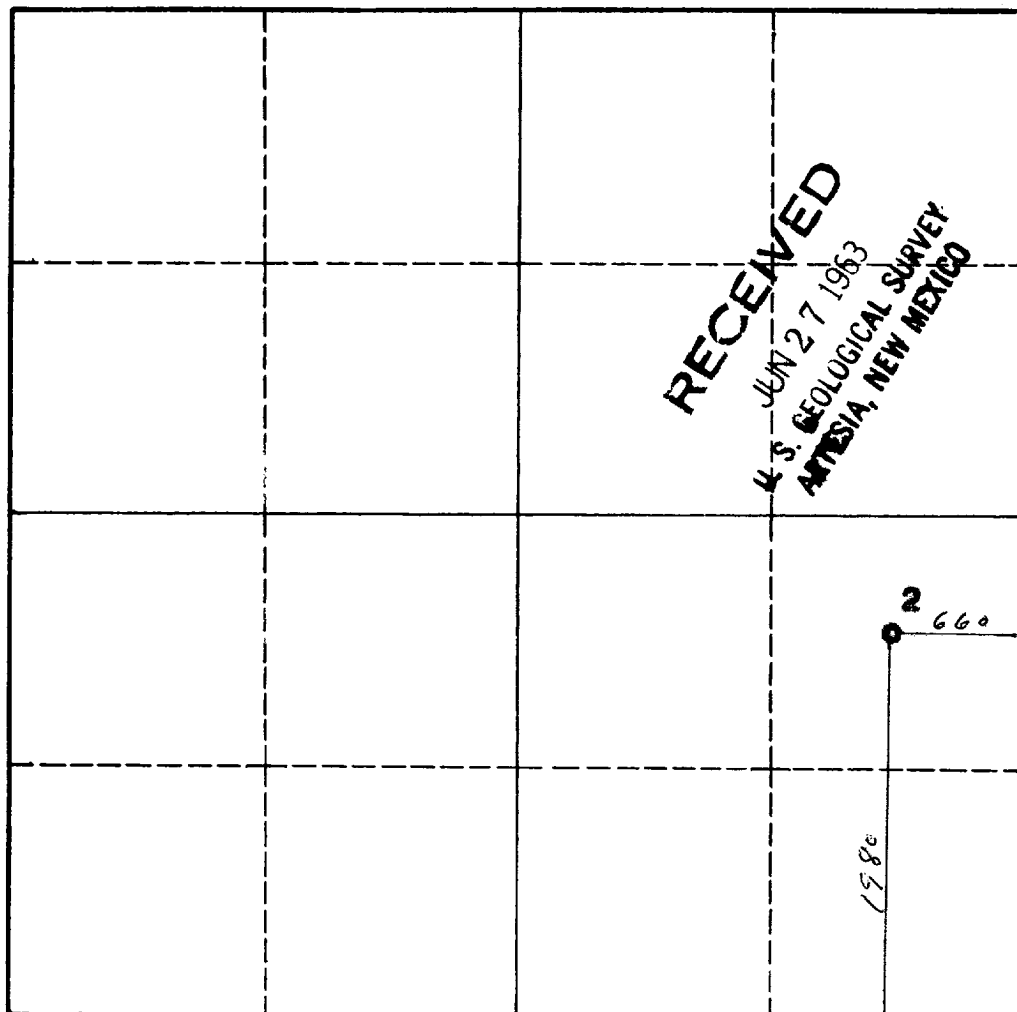
