On November 30, 1964, ran 3" tubing and set Halliburton packers at 3638' and 3771'. Fraced perforations at 3927-51 with 5,000 gallons of gelled water plus 2,500# sand. Treated at 10 1/2 bbls./min. at 2600 psi. Fraced perforations at 3695-3718 with 5,000 gallons gelled water plus 2,500# sand. Treated at 9 1/2 bbls./min. at 2900 psi. On Dec. 2, 1964, the well took 223 bbls. water at 1600 psi., so it appears the treatment was satisfactory.

Instructions
