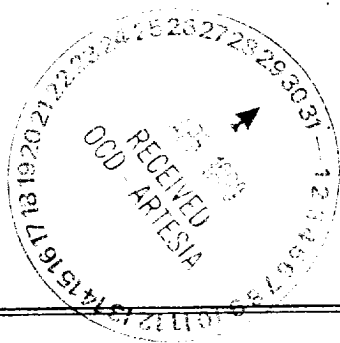

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Well is currently injecting into intervals from 3640' - 3927'. We propose to set a CIBP at 3625' and perforate the Grayburg from 3303' - 3516' gross interval, acidize with 2000 gallons, frac with 60,000 gallons gelled H2O carrying 107,000 pounds sand.
