1. Pulled rods and pump, checked TD @ 3167' and pulled tubing.
2. Ran GR-R log from 3150-2980. Perforated 5-1/2" casing w/2 JSPI @ 3109, 35 and 2613, 20, 38 & 49'.
3. Ran 2-7/8" tubing w/RBP and packer, w/RBP @ 3101 and packer @ 3050'. Acidized perforations 3109-35 w/500 gals. 3% HF & 12% HCL acid. Fraced w/10,000 gals. gelled brine & 10,000 # 20/40 sand. Moved RBP to 2700' & packer to 2570'.
4. Acidized perforations 2613-49' w/500 gals. 3% HF & 12% HCL acid. Fraced w/10,000 gals. gelled brine & 10,000 # 20/40 sand. Pulled tubing, packer & RBP.
5. Ran 2-3/8" plastic-lined tubing w/packer set in 5-1/2" casing @ 2544'. Loaded casing annulus w/42 bbls. treated fresh water. Pressured to 500# on casing. 30 minutes, 4-5-74. Held OK. Connected up for injection.
6. Conversion to injection completed 4-5-74.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
