6-17-88 TIH with spear on tubing. Tag packer and push to 2650'. TOH with no recovery of fish. Set 5-1/2" CIBP @ 2570' (top perf @ 2613'). Cap with 35' of cement with dump bailer. PBTD 2535'. Circulate 5-1/2" casing with inhibited water. Test 5-1/2" casing to 500 psi for 30 min. - OK. TOH with tubing. Rig down pulling unit.

Packer left in hole at 2650'.
