Well is currently injecting into intervals from 3640' - 3881'. We propose to set a CIBP at 3630' and perforate the Grayburg from 3277' - 3510' gross interval, acidize with 2000 gallons, frac with 48,000 gallons gelled H<sub>2</sub>O carrying 130,000# 20/40 sand.
