Well is currently injecting into intervals from 3678' - 3926'. We propose to set a CIBP at 3663' and perforate the Grayburg from 3325' - 3566' gross interval, acidize with 2000 gallons, frac with 60,000 gallons gelled H2O carrying 107,000 pounds sand.
