Propose to plug & abandon as follows:

1. TOH with tubing.
2. TIH with wireline set CIBP an set CIBP @ 2396'.TOH. TIH with tubing tag CIBP load hole with plugging mud. Spot 25 sack Class C cement plug from 2106-2396'.
3. Perforate 4-1/2" casing with 6 holes @ 1100' & 6 shots @ 451'.
4. TIH with wireline set cement retainer & set retainer @ 1050'. TOH. TIH with tubing sting into retainer & establish an injection rate. Squeeze with 75 sacks Class C cement. Leave 35' of cement on top of retainer. TOH with tubing.
