1. Set cast iron bridge plug and 35' at 2107' (6 sx "C")
2. Set cast iron bridge plug and 35' cement at 1350'. (6sx "C")
3. Class C cement plug 1125'-1000'. (25sx) Tag plug.
4. 10 sx class "C" surface plug. (60' to surface.)
5. Dump additional cement on retrievable bridge plug. (4sx)
