This well was drilled and previously operated by David Faskin. It is now plugged back to approximately 2,840' where Yates Petroleum Corporation will assume responsibility as operator. We propose to clean out the well, log, run cement casing, selectively perforate and treat the Yeso formation as required to obtain production. Production casing (5½") will be set at approximately 2500' and cemented with sufficient volume to circulate to surface.

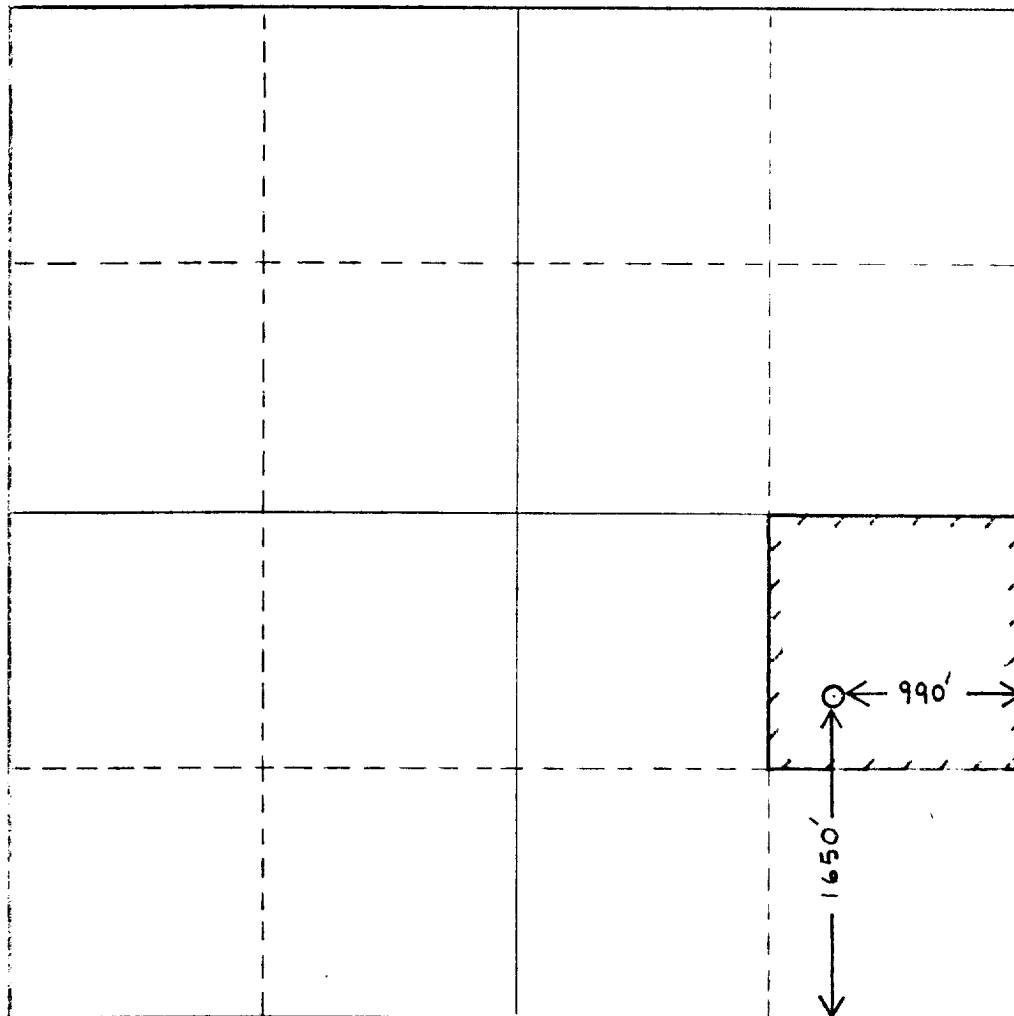
