Drilling procedure proposed:

1. Set 1 joint conductor @ approx. 35' and cement to surface using rat-hole.
2. Drill to 700' with 11" hole using rotary rig.
3. Reduce hole to 7-7/8" and drill no deeper than 2000' to evaluate formations.
4. If well is considered to have productive possibilities in deeper horizons:
 - a. Application will be made to drill deeper and,
 - b. 8-5/8" casing will be set at 700' and cemented as outlined above.
5. If well is dry and no additional drilling is planned below 2000', application will be made to plug and abandon using plugging procedure as recommended.
6. No completion string of casing will be run without first setting and cementing surface casing to approx. 700 feet.

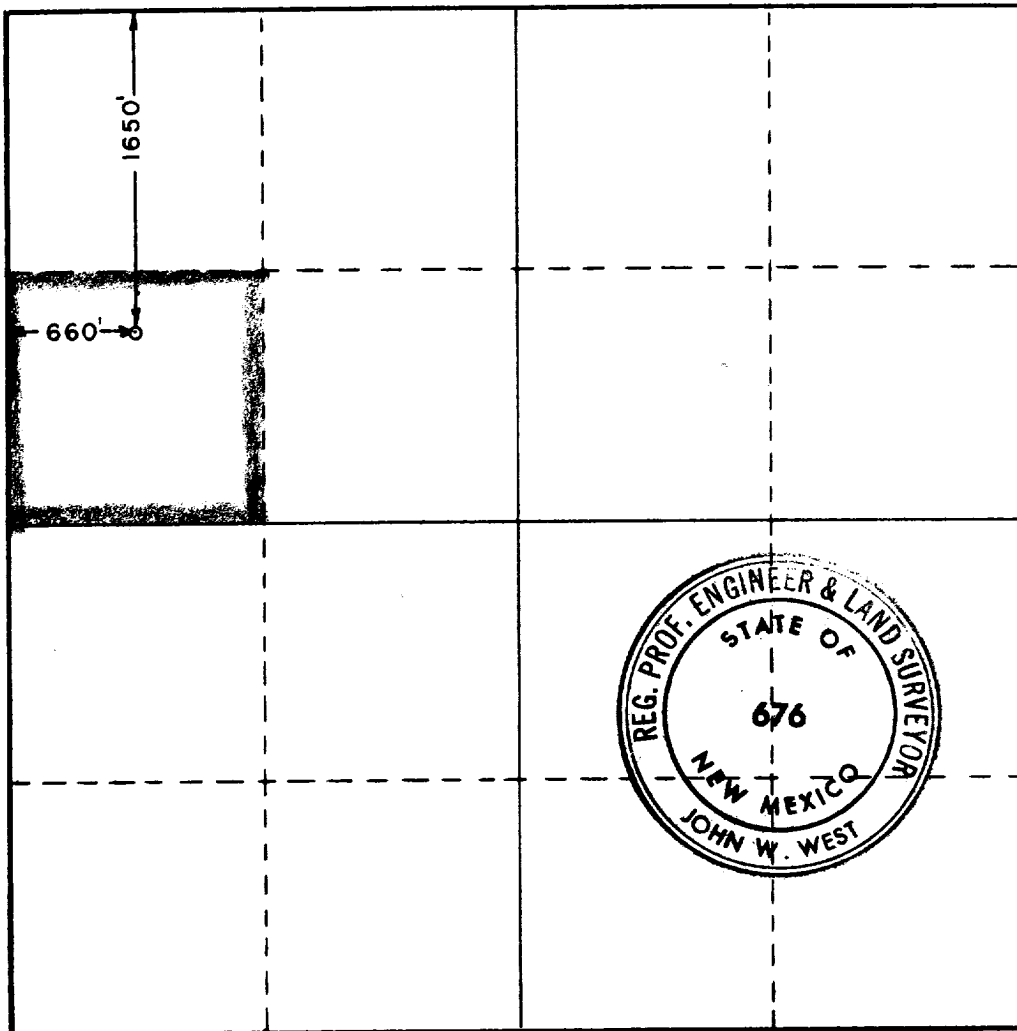
