1. Drilled 7-7/8" hole to 8710'. Reached T.D. 1-19-74. Drill stem tested following intervals: DST #1 - 7106-7140' DST #3 - 8434-8488'
DST #2 - 8198-8246' DST #4 - 8500-8550'
2. Ran following Schlumberger logs: FDC-CNL, DLL, & Dip Meter.
3. Ran 251 jts., 8600', of 4 1/2", 11.6# & 10.5# casing, set @ 8595'.
4. Cemented with 275 sxs. Class "H" with 7.6# salt/sack, plus 1% Halad-9. Plug down @ 10:55 a.m., MDT, 1-22-74.
5. Cut off, nipples up, & tested tree to 4000 psig - held OK.
6. Perforated 8231-8241' with 4 jets per foot.
7. Ran 256 jts. 2-3/8", J-55, Buttress tubing (8033.92') with Baker Lok-Set packer. Set at 8062.19' K.B.
8. Swabbed, tested, acidized with 1000 gals. M-S acid, cleaned up and tested.
9. Ran 4 point test. C.A.O.F.P. = 760 MCF/day (3-22-74).

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
