Perforated 1376-1426' w/20 .50" shots (Slaughter zone). Treated perforations w/60000 gallons of gelled 1% KCL, 95000# sand, 75000# 20-40 sand and 20000# 100 mesh. Hung well on beam and put well back to producing.

Production has increased from 1 BOPD to 35 BOPD.
