3. RIH w/Lok-set pkr on tbq, set pkr @ 9125'.
4. Acidize perfs 9150-60' w/3000 gals 7 1/2% MS acid plus 1000 SCF N₂/bbl. Test.
5. Reset pkr @ approx 8903', loan annulus w/treated water, swab test.
