THIS IS A CORRECTED REPORT FOR THAT ONE SENT IN 6-22-76

We will squeeze the depleted zone from 8840-8848' with 100 sacks Class H, 6/10 of 1/4 Galad-9 followed by 50 sacks Class H, 5 lbs/sk salt. The squeeze will be performed with the use of an SI-EZ Drill. We will WOC for 18 hours, and then Drill Retainer and cement and test. We will squeeze to 2,000 . PSI. We will then perforate interval from 8,900 to 8916' with Casing run. A Baker packer will then be sent at 8870'. The zone will be broken down and then swabbed.
