We squeezed the depleted zone from 8840-8848' with 100 sacks Class H, 6/10 of 18 Haled-9 followed by 50 sacks Class H, 5 lbs/sk salt. The squeezed area was performed with the use of an SF-EZ Drill. The well was WOC for 18 hours, and then Drill Retainer and cement and tested. The squeezed area was tested to 2,000 PSI. (SEE REPORT DATED AUGUST 5, 1976)
