1. Rig up rotary tools.

2. Drill approximately 350', set and cement 8-5/8" casing, install and test Series 900 double ram hydraulic blowout preventor.

3. Drill to T. D., 2,800'.

4. Set and cement 4 1/2" casing on T. D.

5. Perforate and acidize Grayburg Zones.

6. Equip for water injection.

7. Commence injection.

\*Note:

This "change of location" is for the purpose of moving away from #20-3. The original application allowed for a distance of 230'. This application relocated the well 549' from #20-3. This should result in recovery of more oil

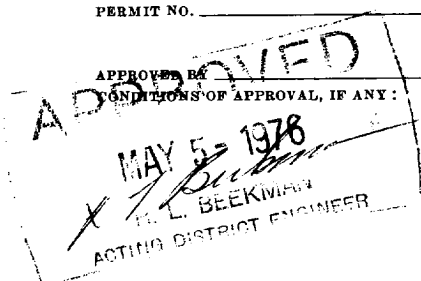

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 1:** If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 14:** Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

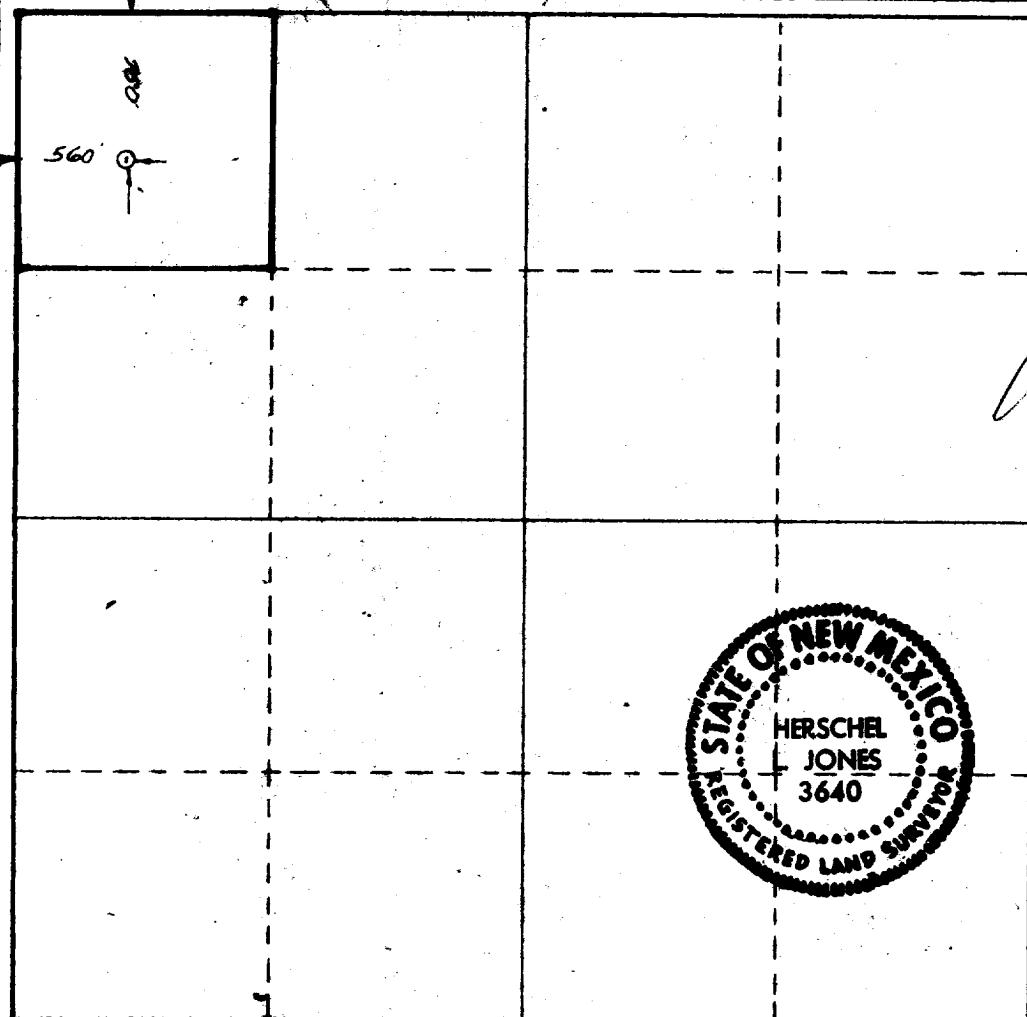
