Gas production from the Morrow Zone at a depth of 11,079 - 11,092 has decreased to approximately 150 MCGPD.

We propose to set "blanking plug" in the top of packer tool @ 11,020' and perforate probable Cisco pay zone from a depth of 9520' - 9550'.

We may or may not reenter the Morrow Zone at a later date. In any event we are aware our setting the "blanking plug" is only temporary, and will require plugging instructions if the zone is permanently abandoned.
