2. Set retrievable bridge plug at 1666' (above Yeso perforations).
3. Perforated San Andres at 1578', 80', 82', 83', 84', 85', 86', 88', 89', 90', 92', 94' (12 holes).
4. Treated San Andres perforations with 2,500 gallons 15% HCL acid, 40,000 gallons gelled 1% KCL water, 7,000# 100 mesh and 45,000# 20/40 mesh sand.
5. Pulled retrievable bridge plug.
6. Ran rods and pumps. Now producing from San Andres and Yeso perforations.
