3. If commercial production is encountered, run 4 1/2" casing and frac for stimulation.

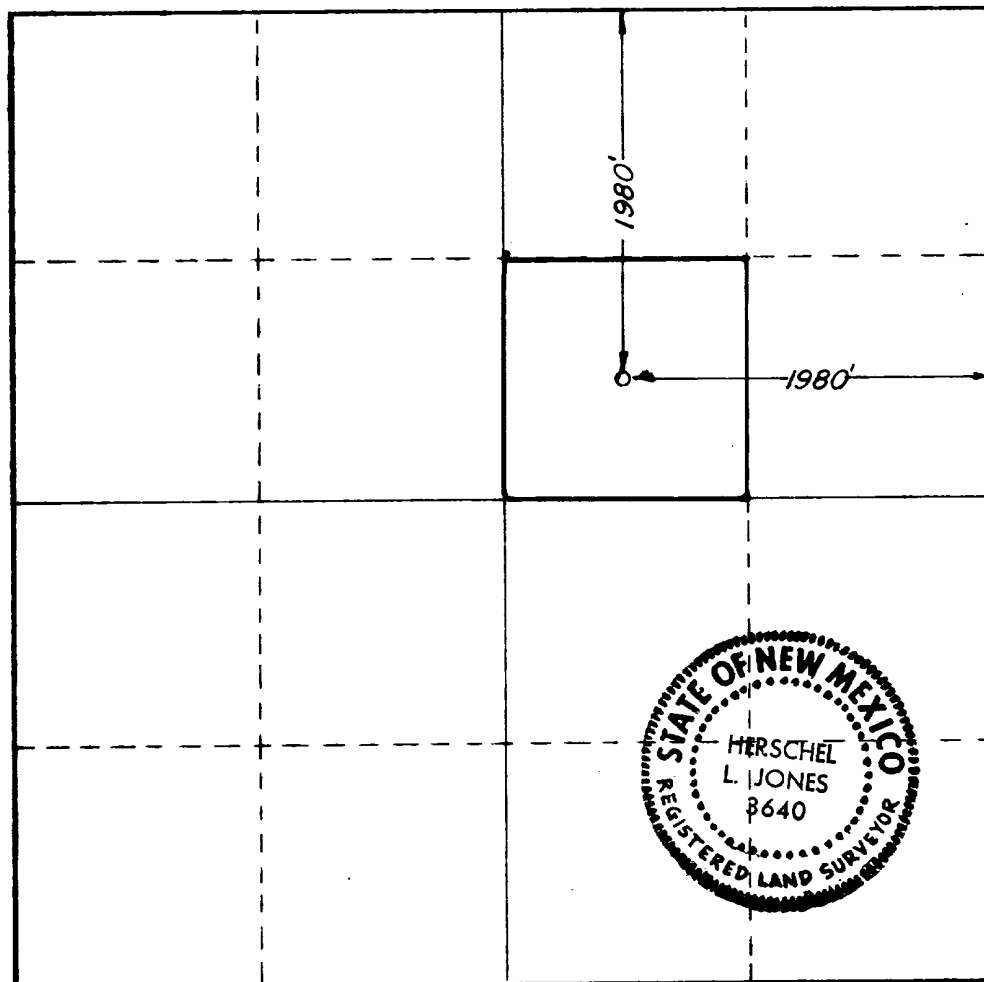

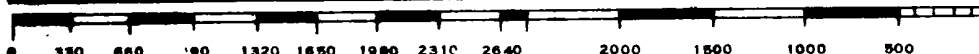
