The following work will be performed on or about June 10, 1980:

1. MIRUPU; install BOP. Blow well down, pull tubing and packer.
2. Set CIBP @ 3800'; dump 35' cement on top of plug. Perforate 3518--3528' (10') w/2JSPF.
3. Run tubing and packer, swab and test.
4. Acidize as necessary, using low pressure and rate.
