TIH with casing guns and perforated 5669-5681' w/48 .42" holes (4 SPF). TOOH with casing guns and rigged down wireline. TIH with packer and 2-3/8" tubing. Spotted 6 bbls 15% NEFE acid at 5681'. Pulled up to 5619' and set packer. Breakdown perforations 5669-5681'. Swabbed.
