2-14-95 - Swabbed. Loaded tubing with 2% KCL water. Try to unset packer, would not unset. Rigged up wireline to freepoint tubing. Free point shows tubing to be stuck at packer. Cut tubing off 15' above packer and TOOH with wireline and rigged down wireline. TOOH with 2-7/8" tubing. TIH with overshot, jars, bumper sub, drill collars and 2-7/8" tubing. Latched onto cut off 2-7/8" tubing at 5610'. Jar packer free. TOOH with 2-7/8" tubing, drill collars, bumper sub, jars, overshot and Uni V packer. Released well to production.
