Our original plans were to P&A this well per Sundry notice dated 08-16-01. We have now decided to plug back the well and test a Grayburg sand during our P&A operations as follows: POOH with rod assembly, pump, 245 jts 2-7/8" tbg and tbg anchor. RIH with CIBP for 5-1/2" casing and set @ 7700' with 35' of cmt on top. Load hole with 9.5# mud. RIH with work string and spot 100' cmt plug from 5200' to 5100' and 100' cmt plug from 4637' to 4537'. POOH. RIH and perforating gun and perforate from 3660' to 3670' w/6 spf. POOH. Frac well. RIH with tbg anchor, 2-7/8" tbg, pump and rod assembly. Place well on production.

We, also, request a 60 day extension to complete this operation.
