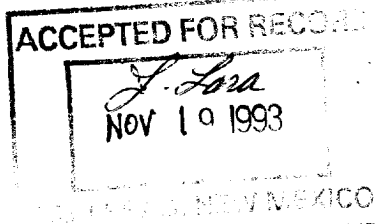

Squeeze existing perforations as follows:

Squeezed Middle Grayburg(3354' - 3362') w/50 sx of Premium Plus cement w/2% CACL to 3000 PSI. Squeezed Penrose (3074' - 3082') w/50 sx of Premium Plus cement w/2% CACL to 2200 PSI. Squeezed Bowers (2648' - 2658') w/150 sx of Premium Plus w/2% CACL to 3000 PSI. Squeezed Seven Rivers (2082' - 2090', 2158' - 2168') w/35 sx of Premium Plus cement w/2% CACL to 1750 PSI. Drill out all cement and retainers. Tested each squeeze separately to 600 PSI. All squeeze zones held. Shut in until injection assembly is run and casing is tested for integrity.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
