On April 21, 1981, we filed Notice of Intention to drill the Puckett "B" #30 well and included a surface use plan. The archeological survey was performed by Dr. J. Loring Haskell. These applications were subsequently approved by the BLM and U.S.G.S.

Drilling has been completed on the well, and the well will be ready to produce within a short time.

Several weeks ago, we requested CVE who furnishes electricity on the lease, to extend their system and connect electricity to this well. They now state that it will be necessary for us to file an amended surface use plan to show their line extension. We are attaching a copy of the CVE staking sheet which shows their present facilities and proposed extension in red. The nearest existing pole is approximately 660 feet to the south of the well pad as shown on sketch. It will be necessary to install 2 poles with 327 feet between poles. This area has been previously surveyed, and we request your authorization to proceed with the extension without any further archeological work.

Your earliest approval will be appreciated since we are being delayed in completing the wells.

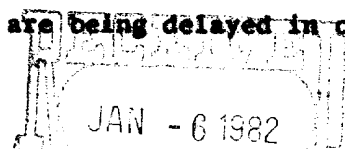

Instructions

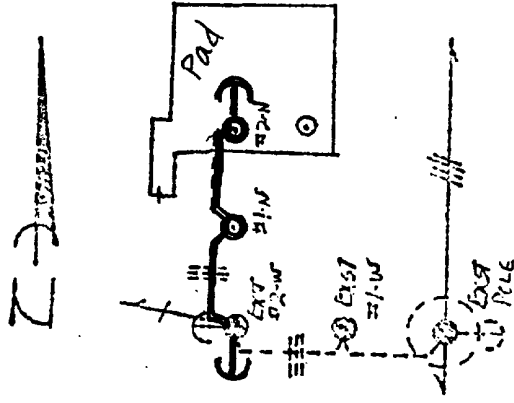
