- 1.) Set CIBP @ 3500' + 35' of cement on top.
- 2.) Cut-off 4-1/2" casing at approximately 1550' and pull out of hole.
- 3.) Set 100' cement plug from 1500' to 1600'. 50' in and 50' out of 4-1/2" casing stub. Tag cement plug.
- 4.) Set 100' cement plug from 466' to 566'. 50' in and 50' out of 8-5/8" casing shoe.
- 5.) Set 50' cement plug from surface to 50'.
- 6.) Install dry hole marker. Clean and restore location.
