5) We believe that it is prudent to have the well as is in the Strawn and Morrow. We believe the Strawn and Morrow are adequately separated in the wellbore and don't believe that fluid will occur between the Strawn and Morrow.
6) It may be mechanically difficult (and expensive) to clean out hard fill and to pull the RBP @ 10700'. If the casing has collapsed, it will be almost impossible to pull the RBP @ 10700' and the packer + SV @ 11751'.
