- 1.) Set CIBP @ 7700' + 35' of cement on top.
- 2.) Cut-off 4-1/2" casing at approximately 5600' and pull.
- 3.) Set 100' cement plug from 5550' to 5650'. 50' in and 50' out of 4-1/2" casing stub. Tag cement plug.
- 4.) Set 100' cement plug from 3482' to 3582'. 50' in and 50' out of 8-5/8" casing shoe.
- 5.) Set 100' cement plug from 1450' to 1550'.
- 6.) Set 100' cement plug from 448' to 548'.
- 7.) Set 50' cement plug from surface to 50'.
- 8.) Install dry hole marker. Clean and restore location.
