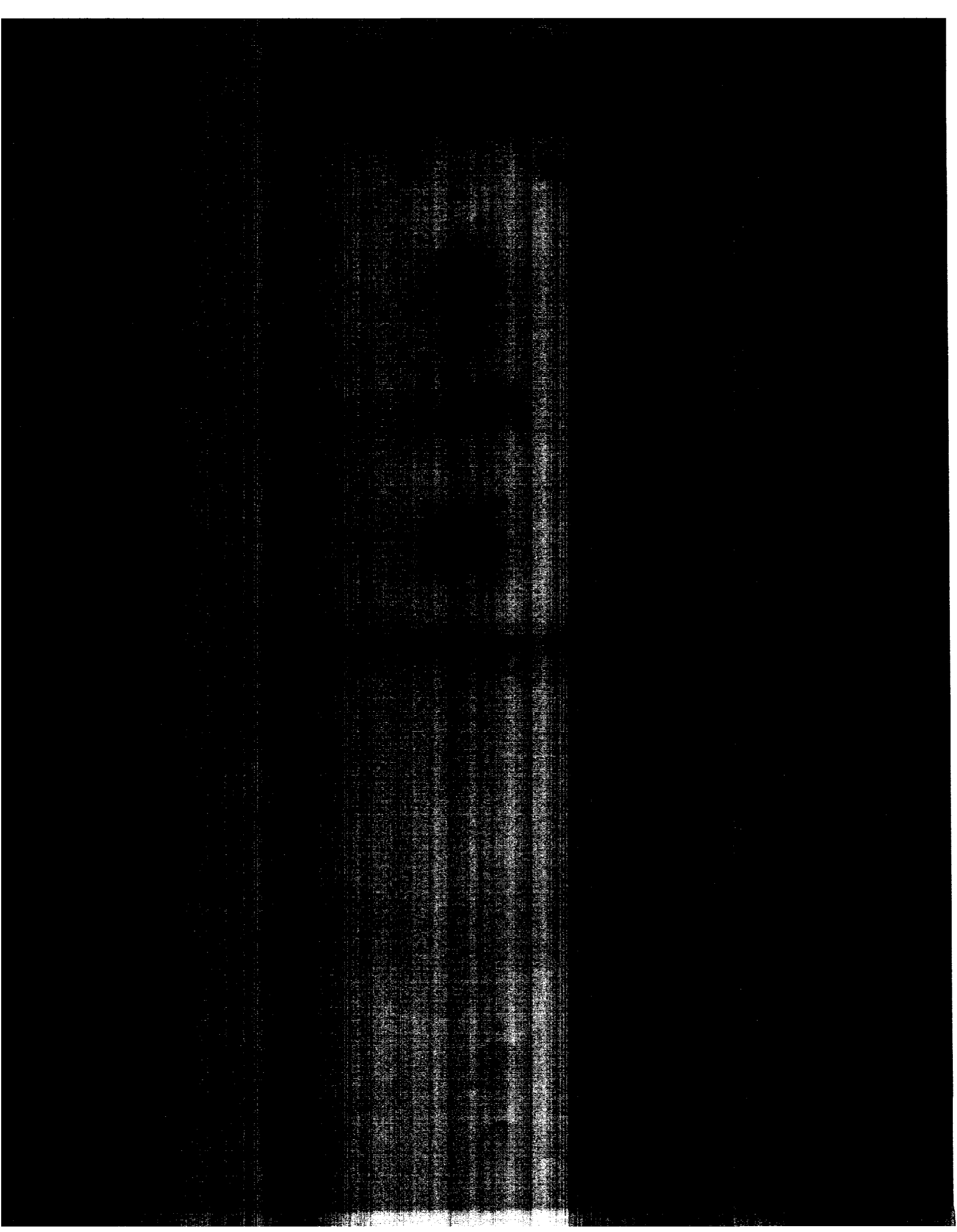

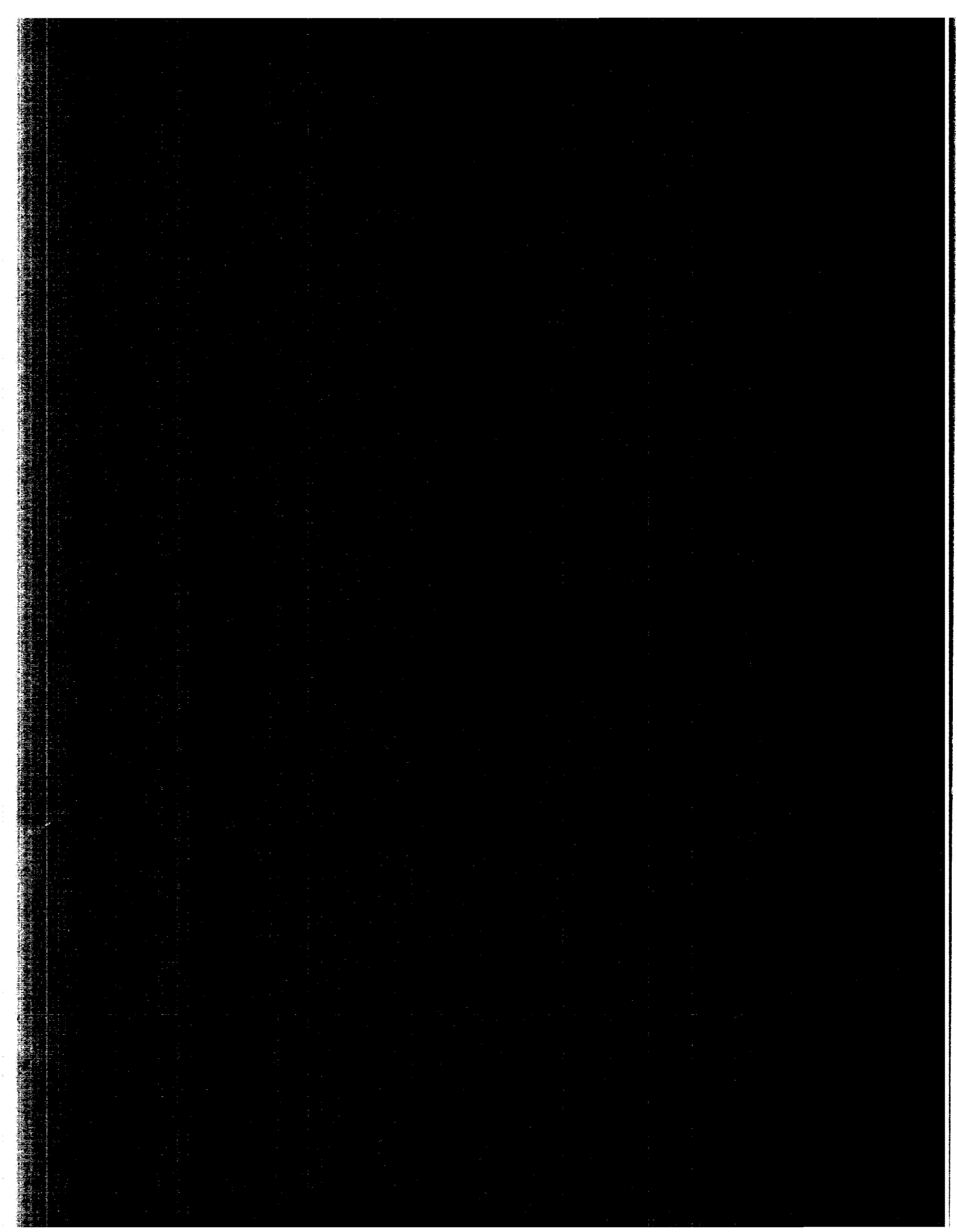

Plugged & abandoned well as per requirements. Ran 2" tubing to 2453'; circulated hole with 10# gelled mud. Spotted 65sx cement plug from 2453' back to 1775' (calculated); trip out with tubing. W.O.C. 2 hours; trip in to tag first plug. Tagged plug at 1800'. Pulled tubing to 975'; filled hole with 10# gelled mud; spotted 25sx cement plug at 975'. Pulled tubing to 400'; spotted 25 sx cement plug. Pulled up and spotted 10 sx plug in and out of casing. Installed and cemented 4" identifying marker. Cleaned up and ripped location; leveled and cut drain slope. Ready for inspection.
