- Spot 25 sx plug from 1300'-1050'. (Base of Salt)
- Spot 40 sx plug from 650'-250'. (Top of Salt and across 8-5/8" shoe)
- Spot 10 sx plug from 100'-Surface.
- Cut off well head and set dry hole marker.

Circulate 10# mud between all plugs.
