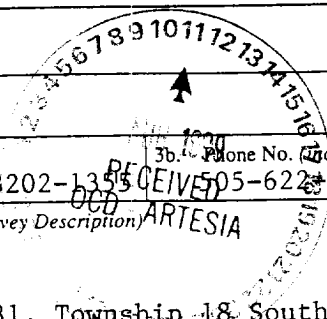

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Operator proposes to plug and abandon the above well and follows:

- 1.) Pull tubing and rods out of hole
- 2.) Set CIBP @ 2400' and cap with 50' cement
- 3.) Set cement plug across base of salt (1200'), 100 ft. plug TAG
- 4.) Set cement plug across top of salt and surface shoe @400', 100 ft. plug
- 5.) Set cement plug from 60' to surface
- 6.) Cut off well head and install dry hole marker
- 7.) Cut off anchors and clean up location
