6-3-87. Set CIBP at 9150' w/35' of cement on top. Perforated 4 squeeze holes at 8410'. Pump 6 bbls 2% KCL at 1-1/2 BPM @1500#. Increased to 3 BPM @1650#. Load 5-1/2" and 8-5/8" with 6 bbls and pressure to 750#, no circulation.  
6-4-87. Set cement retainer at 8363'. Mix 200 sx Class "C" w/3% salt and .4% Halad-4. Stung into retainer and started displacing. Had full circulation from surface casing. Displaced cement and reverse out. POOH. Wait 6 hrs.  
6-5-87. WIH and perforated 8068-8106' w/27 .42" holes as follows: 8068-74', 8081-88', 8095-8106'.  
6-6-8-87. Swabbed well with slight show of gas.
