3-13-91 POH w/BP. RU Halliburton WL & perf'd carbonate zone as follows: 7698, 7700, 7706, 7710, 7713, 7717, 7719, 7721, 7724, 7726, 7728, 7730, 7732, 7735, 7737, 7739, 7741, 7745 & 7747 (19 holes). Ran Baker WL BP & set @ 7755'. WIH w/RTTS pkr to 7747'. Spotted 100 gal acid over perms. PU & set pkr @ 7545'. Removed BOP & installed tree. Acidized perms 7698-7747' w/3000 gals 15% NeFe acid. Pumped 71 BA @ 4.9 BPM & 30#. AIR 5.2 BPM. Max 2400#, min 20#, avg press 912#. ISIP 750#, 5 min-vacuum. Load to recover 295 BW.


