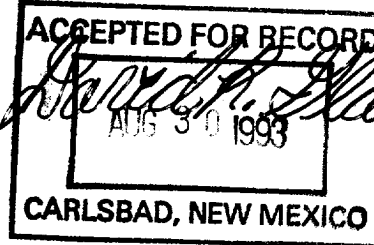

On 8-10-93, we spud this new well at 1230 hours. On 8-12-93, we set 1155' of 8 5/8", 24 ppf, J-55, 8rd ST&C casing in a 12 1/4" open hole. The casing was cemented to surface with the following cement systems:

370 sx LITE (35:65) + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2

We circulated 150 sx of cement to the pit.
