On 8/25/93, we reached TD in this well at 3000' and ran 3000' of 5 1/2", 15.5 ppf 8rd ST&C casing (67 jts) in a 7 7/8" open hole. The casing was cemented with the following cement slurries:

130 sx LITE (35:65) + 6% gel + 10% salt + 1/4 lb/sk cellophane flakes

300 sx Class "C" 3% salt + 0.3% fluid loss additive + 1/4 lb/sk cellophane flakes

We did not circulate cement to surface. Estimated top of cement = 150' from surface.
