Well treated @ approximately 1200 psi. Started swabbing back acid emulsion and oil. Continued to flow back load. RIH w/tubing w/SN @ 3097. Run pump and rods and started to production test. Production test on 10/3/95 48 BO, 5 BW, and 33 MCF. Well returned to producing status.
