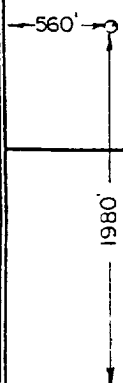

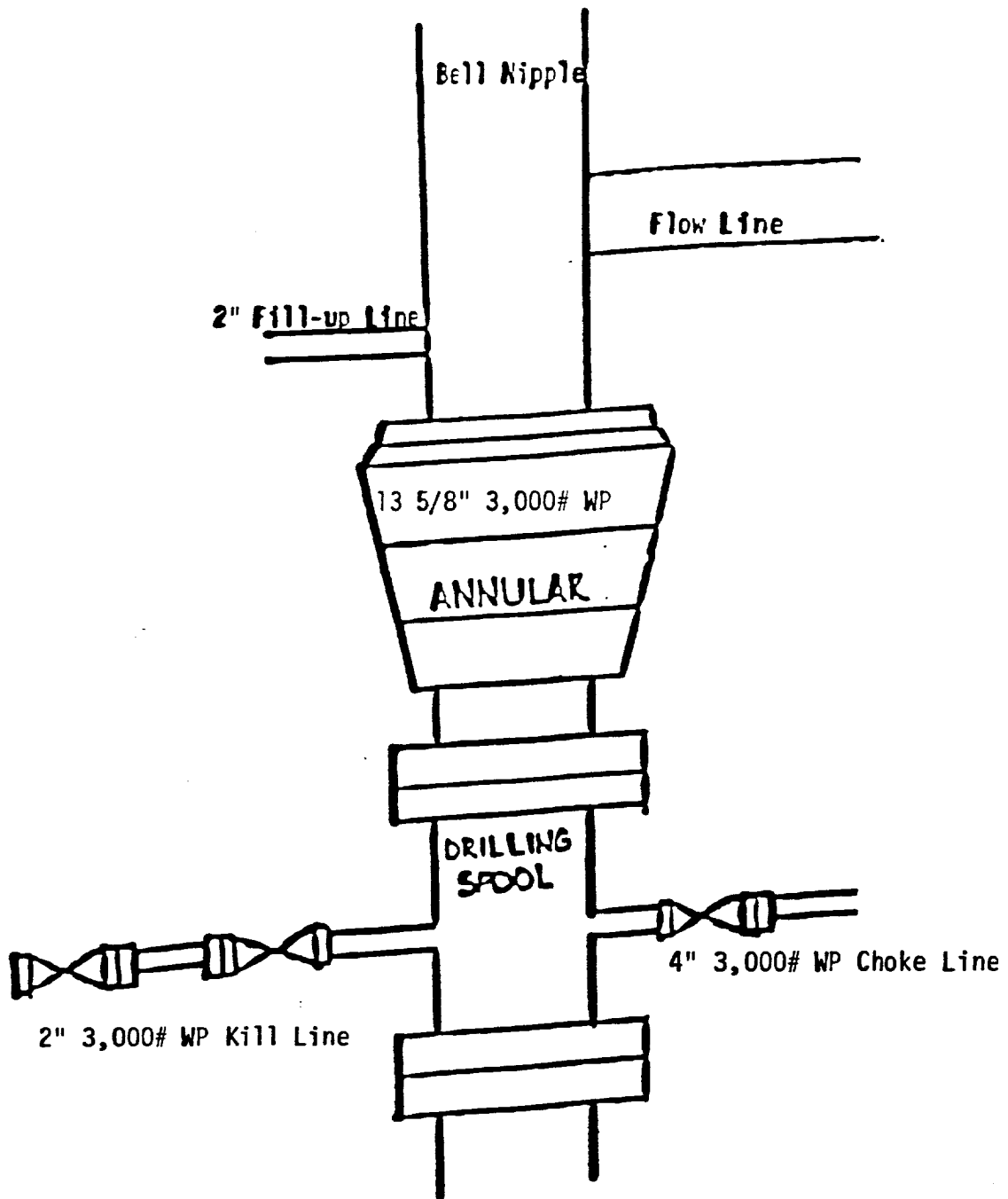

BOP SCHEMATIC

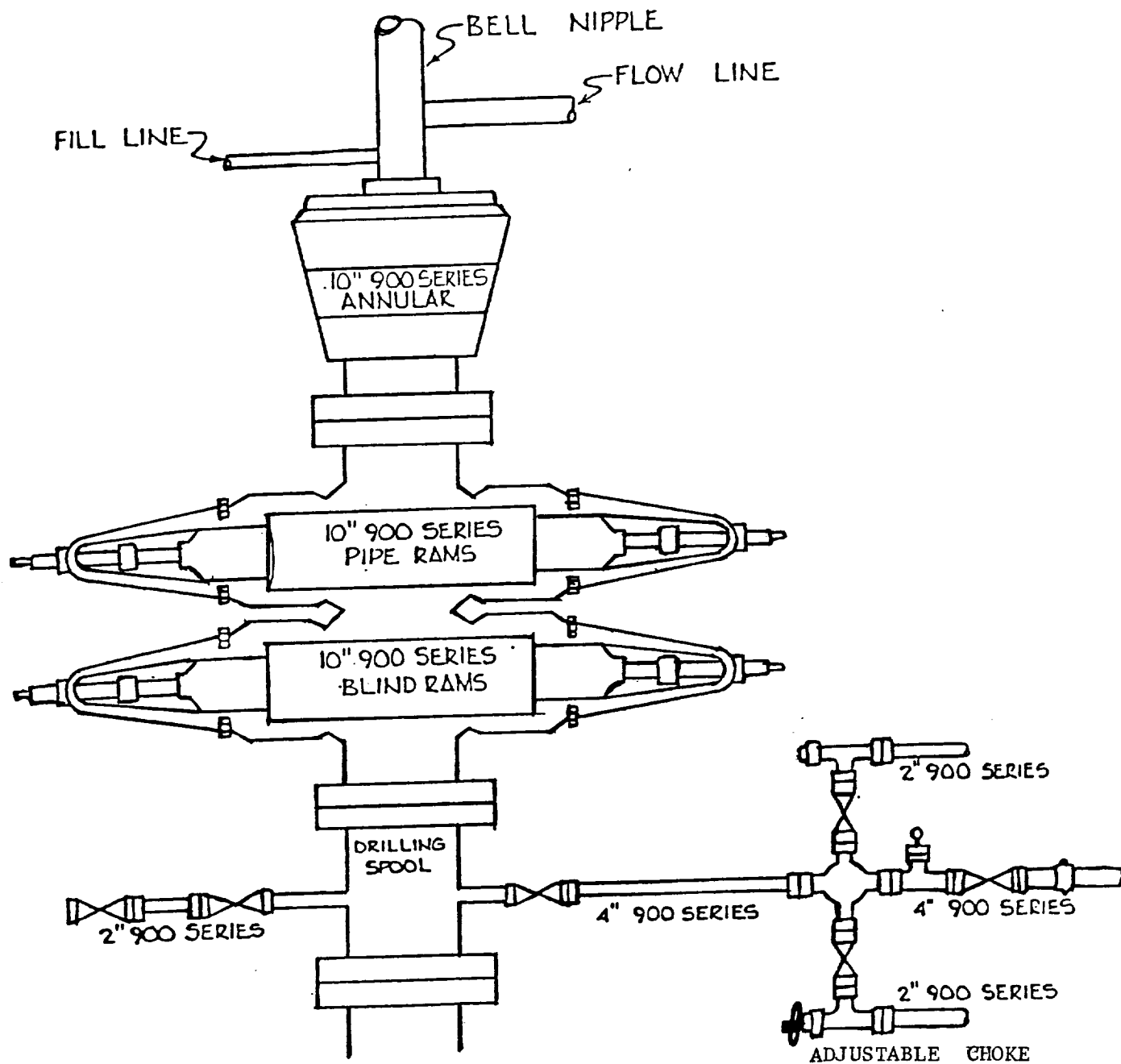
12 1/4" INTERMEDIATE HOLE

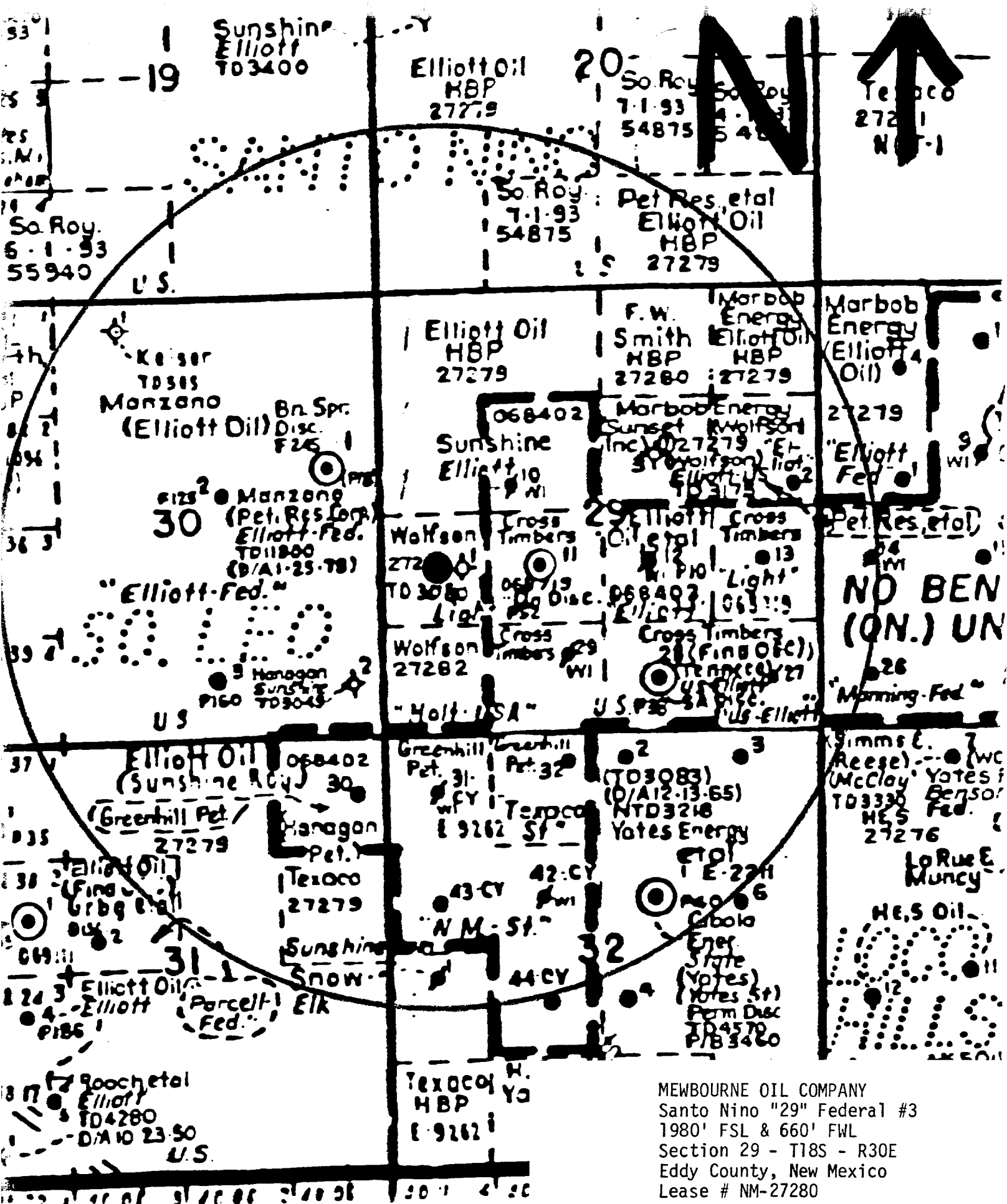
BOP AND CHOKE MANIFOLD SCHE, 1C
