TIH to 4125' & circulated hole clean w/2% KCl. TOH & RD unit. Circulated annulus w/2% KCl & TOH. RIH with 2-7/8" tubing (92 jts) with SN at 2880'. Started pumping load back. Waited for load to be recovered and then put well on production test. Producing rate after acid job is 50 BO, 0 BW, and 40 MCF. Returned well to producing status.
