1/15/95 RU Western Atlas & run CNL-GR and CBL-GR cased hole logs. Circ hole clean w/2% KCl and perforated as follows: 2960-2962'; 2970-2972'; 2982', 2984', 3000', 3003-3004'; 3008-3011'; 3022'; 3026-27'; 3030-3031'; 3044-45'; and 3048-3052' (total of 27 holes). Acidized perfs with 4000 gallons 15% NEFE acid with 50 ball sealers. Flowed back and started swabbing.

1/19/95 Fluid level 500' from surface with 300' of oil on top. Swabbed well down and swabbed 500'/hr. with 40% oil cut. TIH w/ 100 jts 2-7/8" tubing with SN @ 3090'.

1/20/95 Run 12' x 2" x 2-1/2" Top Hold Down Pump, 79 - 3/4" rods, 44-7/8" rods, connected electricity and started well to pumping to flow back load.
