MIRU McGee Drilling Co., Rig #2. Spudded 17-1/2" surface hole @ 5:00 p.m., 10/22/95. Drilled hole to 405' K.B. Ran 13 jts. of 13-3/8", 48#, H-40, ST&C new csg. and set @ 405' K.B. Halliburton cemented with 100 sks. of Thixset + 200 sks. of Class "C" Lite containing 1/2#/sk. flocele + 1#/sk. gilsonite + 3% CaCl2 followed by 200 sks. of Class "C" Neet w/3% CaCl2. Plug down @ 4:00 a.m. 10/23/95. Did not circulate cement. BLM was notified but were not present. WOC 6 hours and ran temperature survey. TOC at 160'. Halliburton cemented with 200 sks. of Class "C" Neet + 3% CaCl2 through 1" at 120'. Circulated 20 sks. of cement to surface. NU BOP and tested BOP and casing to 600# for 30 min., held ok.

Drilled 12-1/4" Intermediate hole to a depth of 1,985' K.B. Ran 48 jts. of 8-5/8", 24#, J-55, ST&C, new casing and set at 1,985' K.B. Halliburton cemented with 600 sks. of Class "C" Lite containing 12#/sk. salt + 1#/sk gilsonite + 1/2#/sk. flocele + 2% CaCl2 followed by 200 sks. of Class "C" Neet containing 2% CaCl2. Plug down at 7:00 a.m. 10/26/95. Circulated 15 sks. to the pit. BLM was notified but wasn't present.
