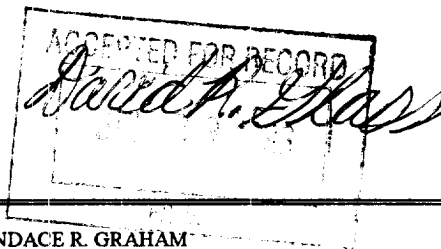

We spud this well on 5-10-96 at 1300 hrs and drld a 12 1/4" hole to 1000'. On 5-12-96 ran 24 jts 8 5/8" 24# J-55 ST&C csg, set at 999'. Cemented w/200 sx Class "C" + 300 sx 35/65 Pozmix "C" + topped out w/2 yds of Redi-Mix. TOC at surface.

Drld 7 7/8" hole and reached TD 2400' on 5-15-96 at 0830 hrs. Schumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 56 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2399'. Cemented w/150 sx 35/65 Pozmix "C" + 375 sx Class "C". TOC at surface.

Released rig at 0600 hrs 05-16-96. WOCU.
