Drld 7 7/8" hole and reached TD 2250' on 10/18/96 at 1800 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 53 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2249'. Cemented w/150 sx lite "C" + 300 sx Class "C". Circ'd 61 sxs cmt.
