We spud this well on 8/20/96 at 1700 hrs and drld a 12 1/4" hole to 1018'. On 8/22/96 ran 25 jts 8 5/8" 24# J-55 ST&C csg, set at 1011'. Cemented w/100 sxs "C" & 300 sxs lite "C" & 200 sxs "C". Circ'd 257 sxs cmt.

Drld 7 7/8" hole and reached TD 2400' on 8/24/96 at 2200 hrs. Schumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 56 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2399'. Cemented w/150 sx lite "C" + 350 sx Class "C". Circ'd 106 sxs cmt.

Released rig at 2000 hrs 8/25/96. WOCU.
