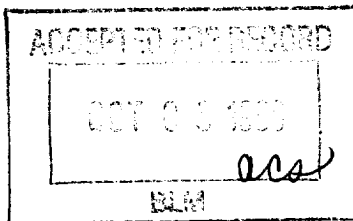

Spudded this well on 9/7/96 at 1945 hrs and drld a 12 1/4" hole to 1088'. On 9/9/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1087'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 98 sxs cmt.

Drld 7 7/8" hole and reached TD 2300' on 9/15/96 at 1030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 55 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2299'. Cemented w/150 sx lite "C" + 250 sx Class "C". Circ'd 75 sxs cmt.

Released rig at 0500 hrs 9/13/96. WOCU.
