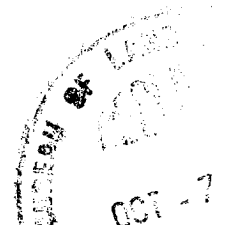
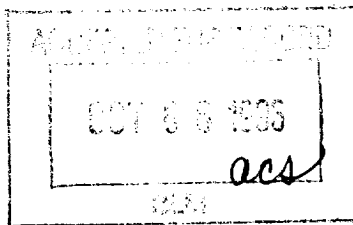

Spudded this well on 9/15/96 at 1330 hrs and drld a 12 1/4" hole to 1105'. On 9/17/96 ran 28 jts 8 5/8" 24# J-55 ST&C csg, set at 1104'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 131 sxs cmt.

Drld 7 7/8" hole and reached TD 2450' on 9/19/96 at 0800 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2449'. Cemented w/150 sx lite "C" + 325 sx Class "C". Circ'd 95 sxs cmt.

Released rig at 0600 hrs 9/20/96. WOCU.
