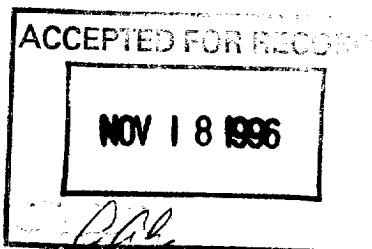

Spudded this well on 10/30/96 at 1800 hrs and drld a 12 1/4" hole to 1066'. On 10/31/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1066'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 120 sxs cmt.

Drld 7 7/8" hole and reached TD 2350' on 11/2/96 at 0330 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 56 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2349'. Cemented w/200 sx lite "C" + 275 sx Class "C". Circ'd 58 sxs cmt.

Released rig at 1930 hrs 11/3/96. WOCU.
