Drld 7 7/8" hole and reached TD 2350' on 10/29/96 at 1700 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 56 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2349'. Cemented w/175 sx lite "C" + 2750 sx Class "C". Circ'd 98 sxs cmt.
