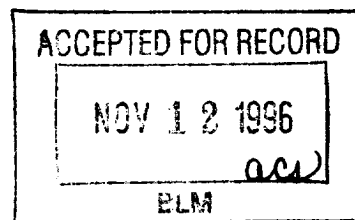

Spudded this well on 10/17/96 at 1230 hrs and drld a 12 1/4" hole to 1074'. On 10/19/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1074'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 73 sxs cmt.

Drld 7 7/8" hole and reached TD 2500' on 10/21/96 at 1600 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 59 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2499'. Cemented w/150 sx lite "C" + 400 sx Class "C". Circ'd 28 sxs cmt.

Released rig at 1530 hrs 10/22/96. WOCU.
