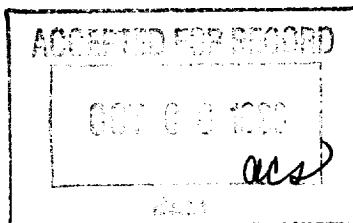

Spudded this well on 9/20/96 at 1700 hrs and drld a 12 1/4" hole to 1082'. On 9/22/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1081'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 147 sxs cmt.

Drld 7 7/8" hole and reached TD 2350' on 9/24/96 at 1500 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 55 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2349'. Cemented w/150 sx lite "C" + 300 sx Class "C". Circ'd 101 sxs cmt.

Released rig at 1030 hrs 9/25/96. WOCU.
